### (1) **GATT**

The GATT Treaty's "*Uruguay Round Agreements*" forced the U.S. Congress to make Social Security numbers mandatory for newborn children in order to be claimed as a dependent on a tax return (Section 742 of Public Law 103-465). Although SSNs have been issued for six decades, new federal regulations in U.S. Code, Title 20, Chapter 111, Subpart B 422.103(b)(2) now allow the Social Security Administration to enter into an agreement with the United Nations Headquarters District to establish "*a procedure to assist SSA in assigning social security numbers to newborn children.*"

[**Note:** "*Treaties*" and your Constitution are both equally regarded as "*The Supreme Law of the Land*"] requires SSN's at birth, after November 30, 1996. See the "*U.S. Legislative History*" of Public Law 103-465 (House Report No. 103-826(1) page 196) where Congress is explaining how they are enacting this Treaty. "Section 2" is entitled: "*Taxpayer identification numbers required at birth (sec. 742 of the bill and secs. 32 and 6109 of the Code)*"

[**Note** that this contradicts a February 1999 Pamphlet by the Social Security Administration. SSA Publication 05-10023 entitled "*Social Security Numbers for Newborns.*" On page 4 it states: "*Getting a Social Security number for your baby is strictly **voluntary.***"
